#### 5. Request Procedure

To request access to any records, a written request must be submitted to the Information Officer, either via email or physical post.

The requester must:

- Use the prescribed Form C (available at <a href="www.justice.gov.za">www.justice.gov.za</a>)
- Provide sufficient detail to identify the record and the requester
- Include proof of identity (copy of ID or company registration)
- Specify the format in which the access is required
- Pay the prescribed access/request fee (if applicable)

#### 6. Grounds for Refusal

Access to certain records may be refused under Sections 62-70 of the PAIA Act, including but not limited to:

- Information that infringes third-party privacy
- Trade secrets or confidential company data
- Legal privilege or ongoing investigations
- Commercial information of clients under NDA
